We FULLY UNDERSTAND that the Activities involve risks and dangers of **SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH** ("expense"); these Risks and dangers may be caused by the Player's own actions, or inaction's, the actions or inaction's of others participating in the Activity, the condition in which the Activity takes place or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; there may be other risks and social and economic losses either not known to us or not readily foreseeable at this time; and **WE FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES** incurred as a result of Player's participation in any Activities
- To the fullest extent permitted by law, we, and each of us, **HEREBY UNCONDITIONALLY, IRREVOCABLY, FULLY AND FINALLY RELEASE, DISCHARGE, COVENANT NOT TO SUE, AND AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS HORIZON COMMUNITY CHURCH**, as well as any and all of their respective employees, officers, directors, members, organizers, sponsors, supervisors, leaders, participants, officials, referees, volunteers, coaches, sponsors, agents and representatives as well any and all other players, other players' parents and legal guardians (each considered one of the "Releasees" herein) from any and all claims and damages, whether direct, indirect, general, special, reliance, incidental, consequential, exemplary or any otherwise, whether in an action based on contract, tort, negligence (active or passive), strict tort liability or otherwise.
